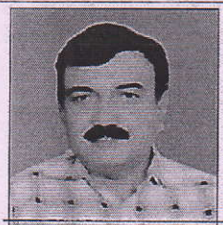

5.3 TREASURER

5.3.2 ~~The Treasurer is the person authorized to receive and also make payments as per the rules and regulations of the Trust and according to the directives of Trustees.~~

5.3.3 The Treasurer has to prepare the statement of accounts and get it audited by the person authorized by the Trustees and submit annually to the Board of Trustees for approval.

5.3.4 The Treasurer shall receive donations, any other amount on behalf of the Trust and issue receipts and make payments.

6. ALLOWANCE AND REIMBURSEMENT TO TRUSTEES & OFFICE BEARERS:

6.1 If at any time any Trustees acts as a whole time office bearer of the Trust or renders any special service, the Trustees may in their discretion pay such remuneration or allowance to him as they may think proper.

6.2 The Trustees or Office Bearers are entitled to be reimbursed and also to pay and discharge out of the Trust Fund, all expenses incurred by them to execute the work of Trust as well as to attend meetings.

7. POWER OF THE TRUSTEES:

7.1 Obtain, manage and secure in the name of the Trust any properties, assets and funds by purchase, gift, lease or grant and possess the same to sell, mortgage or lease out the same, provided in case of purchase or sale of properties the consent of majority of the Trustees has been obtained.

- 7.8 To appoint or remove ~~constitute attorneys~~ to settle legal matters and represent the Trustees in connection with any legal or other proceedings.
- 7.9 To appoint or remove any person, agency or a charitable organization to run and manage any institution established by the Trust.
- 7.10 To appoint new member or members of Board of Trustees by a resolution and to discharge any of the Trustees, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee, by resolution passed by simple majority of members present and voting in the meeting of Board of Trustees.

8. RULES OF THE TRUST:

- 8.1 The Trustees may from time to time frame rules:
- 8.1.1 For the conduct of their own meetings and business.

- 8.2.1 All matters will be decided by majority and two Trustees shall form a quorum for meeting of Trustees provided however, if the number of Trustees falls below two, then for the purpose of appointing a Trustee, one will be quorum.
- 8.2.2 Resolution passed without any meeting of the Trustees and evidence in writing under the hands of three-fourth of the Trustees or the number nearest thereto shall be as valid and effectual as resolution duly passed at the meeting if the Trustees.
- 8.2.3 The existing Trustees may appoint one or more Trustees at their discretion from time to time, but in any case, the total number of the Trustees, including the new Trustees appointed, shall not exceed five.

- 9.1.6 Administrative charges from Schools, Colleges, Hospitals, Institutions, etc. or any other income which may accrue in the working of any other institution controlled by the Trust.
- 9.1.7 Donations/Gifts received from individuals, institutions and foundations.
- 9.2 The funds and the income of the Trust shall be solely utilized for the achievement of the objectives of the Trust and no portion shall be utilized for payment to the Trustees by way of profit, interest, dividends, etc.
10. **ACCOUNTS, AUDIT AND MINUTES:** The Trustees shall maintain true and correct accounts of all receipts and payments and dealings in regard to the Trust property and shall also maintain the correct records of their meetings and deliberations. Accounts shall be audited every year by a Chartered Accountant appointed by the Board of Trustees. The accounting year shall be from 1st April to 31st March of every succeeding year.
11. **MEETING:**
- 11.1 The meeting of the Board of Trustees shall be held at least four times in a year or more number of meetings may be called if necessary. The meeting may be held at any place in India at discretion of the Chairman of the Board.
- 11.2 A minute book shall be kept by the Trustees wherein entry of all the proceedings of the meetings of the Board of Trustees shall be made which shall be signed by the Chairman of the meeting either at the conclusion thereof or at the next meeting.
- 11.3 All questions relating to management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by a majority of the Trustees present and voting in any meeting of Board of Trustees or by the circulation, as the case may be and any such decision of

12. **INDEMNITY:** The Trustees shall be kept fully indemnified and harmless by the Trust against any loss suffered or liability arising against the Trust for anything done by them in good faith pursuant to the power and authority conferred on them by this Deed.

13. The Trust is irrevocable.

14. In case of death or retirement or resignation or termination of any one of the Trustees, a new Trustee may be appointed to fill the vacancy so caused.

15. The activities of the Trust will be only within India.

16. **DISSOLUTION:** In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees but the same shall be transferred to another charitable, religious, Trust, society, association or institution whose objects and faiths are similar to those of the Trust and which enjoys recognition u/s 80G of the Income Tax Act, 1961 as amended from time to time.
